Abortion care for undocumented immigrant minors & the best interests of the child

Alexandra Carter, MPH Candidate Health & Social Behavior, UC Berkeley School of Public Health Unaccompanied Immigrant Minor (UIM): "those who are separated from both parents and not cared for by an adult who by law or custom has responsibility to do so" (UNHCR).

Unaccompanied Alien Child (UAC): "children who lack lawful immigration status in the United States, who are under the age of 18, and who either are without a parent or legal guardian in United States or without a parent or legal guardian in the United States who is available to provide care and physical custody" (ORR).





Figure II. Apprehensions by Gender





Best Interests of the Child

United Nations Convention on the Rights of the Child (CRC), 1989

Article 3. The best interests of the child shall be a primary consideration in all actions affecting children, whether undertaken by public or private social welfare institutions, courts of law, administrative authorities, or legislative bodies (UNHCR, 2008).

Homeland Security Act (HSA) of 2002

"As mandated by law, ORR places an unaccompanied alien child in the least restrictive setting, that is in the best interests of the child" (ORR, 2017).



What is in the best interest of an unaccompanied minor when faced with an unwanted pregnancy?

Methods

Review of relevant literature: PubMed, Web of Science, Contemporary Women's Issues, HeinOnline, and Google Scholar databases.

Criteria: articles published in English within the last 10 years, specific to unaccompanied children in the U.S. from Central America. Peer-reviewed research on health outcomes of abortion and adolescent childbirth.

Grey literature: government websites, legal documents, news articles, UN reports and human rights instruments.



Conclusions & Recommendations

ORR's abortion policy violates the best interests of UIMs

- Immediate revision of ORR's abortion policy
- Guidelines for conscientious objection by service-providers
- Universal standards for clinical screenings and care
- Greater transparency of government data and service provision

• More research on the reproductive health needs and experiences of UIMs

"My name is not Jane Doe, but I am a Jane Doe."

I'm a 17 year old girl that came to this country to make a better life for myself. My journey wasn't easy, but I came here with hope in my heart to build a life I can be proud of. I dream about studying, becoming a nurse, and one day working with the elderly. When I was detained, I was placed in a shelter for children. It was there that I was told I was pregnant. I knew immediately what was best for me then, as I do now – that I'm not ready to be a parent...No one should be shamed for making the right decision for themselves. I would not tell any girl in my situation what they should do. That decision is hers and hers alone.
